A Look Back at the Academy's Founding as We Celebrate Our Twentieth Anniversary

The 2010/2011 academic year marks the twentieth anniversary of the Aiken Academy for Lifelong Learning's first full year of operation. As this milestone is reached, our members might be interested in the events that led to the founding of the Academy.

In the summer of 1989 the dreams of three individuals merged and began to take shape. Ida Crawford Stewart, then Vice President of Estee Lauder, Inc., is a native of South Carolina and a former resident of Aiken. She expressed the strong belief that people of all ages should continue to maximize their individual potential. To further this belief, she established an irrevocable trust at the University of South Carolina-Aiken (USCA) to create a Chair in the Department of Sociology in Gerontology.

Dr. Robert Alexander, Chancellor of USCA at that time, agreed with Mrs. Stewart and asked Dr. Mary Leslie Hudson, then Dean of Continuing Education at USCA, and Dr. Trudy Henson, then Chair of the Sociology Department at USCA, to present a plan by which USCA could serve the rapidly growing population of older persons within the university's service area.

Into this scene came Dr. Earl F. Kauffman who, at the age of 82 years, was seeking a new challenge. Dr. Kauffman had served for 25 years on the faculty of the University of Kentucky (U.K.), during which he organized the Council on Aging at U.K. Following his retirement from U.K., he continued to work on behalf of the elderly and organized the Community Activity Program at Hawthorne-at-Leesburg, an adult community in central Florida. Upon his arrival in Aiken, he held a series of conferences with leaders serving older persons in the Aiken area. From these meetings he recruited members for a planning committee to develop and implement a program for the community's mature residents. Working under the direction of Dr. Kauffman, this committee, composed of mature learners from the Aiken community, formulated a mission statement for what was to become the Academy for Lifelong Learning: "To provide opportunities for men and women to get the most out of their lives." By late January of 1990 the Academy was ready to offer opportunities for people sixty years of age and older to come back to school "to learn without having to take tests".

January 22,1990 was the inaugural meeting of the Aiken Academy for Lifelong Learning. Dr. Warner Montgomery, editor of the *Star Reporter* in Columbia, SC., spoke before more than 300 persons at the Etherredge Center on the USCA campus. Dr. Montgomery's topic was "Preparing for the Next Century --The Maturity Spiral", a discussion of the pace of change in our society.

In the ensuing months interested members formed focus groups to identify projects of major interest to Academy members. A monthly newsletter was established to provide news about programs, members, and special USCA resources and events. *The Maturity Spiral*, taken from the title of Dr. Montgomery's January address, was chosen as the name for the newsletter, as it seemed to capture the rhythm and meaning of the Academy program. In 1997 the name of the newsletter was shortened to *The Spiral*.

In 1990/1991, the first full academic year of operation, the Aiken Academy for Lifelong Learning attracted 125 members who attended more than 25 forums, field visits, and special events.

Dr. Kauffman served as Director of the Academy until his death, shortly after the beginning of the Academy's initial Fall term, on October 19, 1990, having successfully established the Academy that was to continue his dream. Every April, the Academy presents the Earl F. Kauffman Award in his honor, to recognize a group or individual that has provided outstanding contributions to the Academy.

By 1993 interest in the Academy had grown rapidly and there were requests to lower the age at which people might join. Responding to this interest, the Board of Regents acted to formalize 55 years as the minimum age for membership. In 1997, the Board of Regents removed the numerical limit and formalized "mature adult" as the age requirement for membership.

In the ensuing years, Academy membership has grown to over 300 seniors from Aiken and nearby communities. The current catalog lists 20 short courses covering a variety of themes such as politics, science, religion, law, health, literature, and leisure pursuits, plus two special events for Academy members, and this is in the Fall semester alone.

Academy members can be proud of this heritage, and with the help of our dedicated volunteers, can be sure that it will continue to extend into the future.

USCA Chancellor to Speak at September 10 Academy General Meeting



Dr. Thomas L. Hallman, Chancellor of the University of South Carolina Aiken, will address the Academy at its General meeting for September. His topic will be Champagne Educational Experiences on a Diet Coke Budget: The USC Aiken Way!, which will address the difficulties of managing a quality education program in light of current economic realities.

Summary of May 14 Board Meeting

This is the first issue of *The Spiral* since the May 14 Board meeting.

President Vince Coughlin called the meeting to order at 9:30 a.m. Those present were: Vince Coughlin, Dick Baxter, Doug Wilson, Glenn Knowles, Wesley Sloan, LaVerne Speca, Kathy Schulz, and Erna Arkin.

The minutes for the March 12, 2010, meeting were approved.

There was no treasurer's report.

OLD BUSINESS

- USCA seems to have a greater need for class space during fall semester than spring semester. For this reason, in the future, we might want to consider offering fewer classes in the fall than in the spring Discussion centered on other possible meeting places, such as the Ruth Patrick Science Center and the Etherredge Center. Kathy will report on the availability of Cedar Creek, should we need to use their facilities.
- If our assigned class spaces are small, Doug will include an article in *The Spiral* concerning limited class sizes. He will urge members to sign up early and make all possible attempts to attend classes for which they are registered. If they are unable to attend, they need to notify Laura.
- Vince has made arrangements to have all of his liaison responsibilities covered for the fall.
- Kathy was reimbursed approximately \$100 for the 12x12 green canopy she purchased for Steeplechase.

NEW BUSINESS

- After much discussion, it was decided that our Policies and Procedures, as well as our By-Laws, will be available on the Academy's portion of the University's webpage. Hard copies can be requested from Laura.
- Fall Programs Glenn reported that in an effort to combine entertainment as well as education in our Friday meetings, Mike Lythgoe has suggested two performers. Rob Foster, from Augusta State University, will play the Japanese bamboo flute at the October meeting, at a cost of \$150. Alan Knight, from Columbia, will play the classical guitar for \$200, in November. Vince moved and Kathy seconded that these expenses be covered by taking \$150 from the University account for the flutist, and taking \$200 from the interest on the Julia Turlow Watson Endowment Fund for the guitarist. This motion was passed.
- Continuation of Friday meetings will be reevaluated next year.
- Vince offered the possibility of contributing some sort of donation to Cedar Creek for the use of their facilities. Kathy will investigate some ideas.
- Elaine Lacy will be asked for a schedule of speakers and topics for the University's lunch programs in the H&S building. LaVerne will follow up. We might also publicize them in *The Spiral*.
- The next Board meeting will be August 13, 2010, at 9:30.
- The meeting was adjourned at 10:20 a.m.

August 13 Board Meeting

President Glenn Knowles called the meeting to order at 9:30 a.m. Those present were: Vince Coughlin, Dick Baxter, Doug Wilson, Larry Peyser, Kathy Schulz, Rick Arkin, and Susie Sadowski

The minutes for the May 14, 2010, meeting were read and approved.

TREASURER'S REPORT

Rick Akin submitted a detailed budget reflecting the increased USCA Administrative Fee per Academy Student.

- Motion to amend the budget to add \$240 Line item for USCA Student classroom computer and Audio Visual assistance carried.
- · Motion to approve the budget as amended carried.
- Vince Coughlin provided an analysis of how the USCA fee per Academy student is calculated. Discussion ensued noting the Board is scheduled to meet with USCA Administrative staff regarding this matter.
- Action: The Academy Board will meet in regular session October 1, 2010 with Vice Chancellor Dr. Deidre Martin to discuss and resolve issues pertaining to student fee calculation.
- Action: Treasurer Rick Arkin was asked to provide a review and capitulation of the Academy's endowments to the University.
- Action: Treasurer Rick Arkin was asked to analyze the effect of the increased USCA Academy student fees on the Academy's ability to maintain or increase scholarship funding.
- The Board discussed allocating 100% of elected Board Member tuition to the Academy Checking Account, which is controlled by the Academy Treasurer.
- Motion to change the Academy Policy and Procedures manual to provide for allocation of 100% of Elected Board Member tuition payments to the Academy Checking Account carried.

COMMITTEES

<u>Curriculum Committee</u>: Susie Sadowski reports some spring 2011 cancellations.

<u>Public Relations</u>: The Academy Booth at the Senior Extravaganza scheduled for September 15 at Odell weeks requires volunteers. Hours are 8AM to 2PM.

 Action: Doug Wilson was asked to provide notice of need for volunteers and Glenn's phone number in the September issue of *The Spiral*.

USCA Open House is scheduled for Wednesday August 18 from 9:00 AM until Noon. Lunch will be provided to volunteers. Susie Sadowski suggested a Free one semester Membership Drawing as a way to generate interest and secure mailing addresses. No Board Action was taken.

Elizabeth Majors has discovered glass display cases on the second floor of the campus library suitable for display. Erna Arkin and Elizabeth Majors will follow up and come back to the Board with a plan and request. No action taken.

Friday Meeting attendance was discussed. We have a fall schedule complete. Glen asked the Board to take a look at attendance at these meetings and provide feedback for discussion at future Board meetings. What can

we do to increase attendance at these monthly general meetings?

<u>The Spiral</u> and Academy Web Site: Doug Wilson advises the September issue of *The Spiral* is ready to go. He will attempt to get it out before the end of the month. Typical deadline for submissions for *The Spiral* is the 15th. The Web Site has corrected class changes.
