# President's Message

All of us, long time members and new, will often enter the breezeways and courtyard of the Penland Building. It is the Robert E. Penland Administration Building, and it has its foundation deep in South Carolina history.

In the 1600 and 1700's generations of two pioneering families, most likely unrelated, were among many who followed the Mayflower, found their way into Pennsylvania, then Virginia, North Carolina and beyond. They followed the eastern side of the Allegheny & Blue Ridge Mountains. Some Sumters stopped at Preddy's Creek, just North of Charlottesville, Virginia.

The Penlands settled only 350 miles further southwest in and around Asheville, North Carolina.

Preddys Creek gave us Thomas Sumter, Indian friend and fighter, rabble rouser, politician, plantation owner and Revolutionary War General......the original "Gamecock".

From that same Irish, Scottish, pioneer heritage John Benjamin Penland (J.B.) found his way from Asheville to Columbia, S.C. He and his wife Isabelle owned and operated a store, mostly groceries. It was located near the corner of Main and College Streets, one block from The Horseshoe, the original campus of the University of South Carolina. The family endeavor was a great place for their children, including Robert Earle, born in 1916, to learn about work and business. The enterprise prospered, growing to a chain of over twenty five stores. Sadly, J.B. died in 1927. Isabelle, strong, and very strong minded, with the help of the children carried on, although she wore only black for the remaining 40 years of her life. When the Depression came, the Penland chain of stores disappeared.

Regardless of the losses, Isabelle was insistent her children would be educated. Robert Earle earned a track scholarship to UNC, but it did not cover room and board. So, he stayed home and attended USC through law school. At the time, a law degree was the only ticket to a job with the FBI, and Robert Earle was intrigued. He spent eleven years learning, traveling and taking part in many interesting investigations. Then a headline in the Washington Post struck. The United States government announced that the largest peace time plant ever to be built was coming to Aiken, S.C. (SRS). With the expectation of a new career, and maybe some homesickness, Robert immediately wrote his resignation from the FBI and hand delivered it to J. Edgar Hoover.

While investigating business opportunities, Bob easily made friends and acquaintances in and around Aiken. His first real estate venture was a small tract at the end of Berrie Road. Next, the neighborhood of Dunbarton Oaks, named for a town swallowed by the new government plant, was developed.

In 1961, thanks to his friend Dorcey Lybrand, Attorney, Bob learned of a desirable 1600 acre stretch of land and they bought it. Westcliff and Foxchase were developed. Many were involved, but by the early 1970's it was only Bob and a visitor to the Masters Golf Tournament who became enamored with the area, Robert Elwood Jones. They are responsible for the Houndslake Country Club and the community surrounding its 27 hole golf course.

Bob was well known for the string of Jeeps he used over the years to show and sell the properties. Buyers, friends, potential investors, community leaders and family were often passengers in a Jeep.

Meanwhile, Bob was also involved with civic affairs. Among them was the Aiken Chamber of Commerce. He was instrumental in bringing the Kimberly Clark and Owens Corning plants to the area. But probably most important in his mind, as it was in his mother's, was higher education. He was among the founders, probably the catalyst, for the Aiken County Commission on Higher Education (ACCHE). That commission's work led to state legislation authorizing a USC campus in Aiken in 1961. In 1966 Bob served as President of the ACCHE. Outgrowing Banksia (Howe family home, 1935, now the Aiken County Historical Museum), a multipurpose building rose in 1972 on what is now University Parkway. The buildOctober, 2010

ing, thought then to be all USCA would ever need, now houses offices for financial aid, career services, USCA Human Resources and Finance, and some academic activities.

In 1999 that first building was dedicated in memory of Robert E. Penland.

## September 10 Board Meeting

President Glenn Knowles called the meeting to order at 12:15 p.m. Those present were: Vince Coughlin, Dick Baxter, Doug Wilson, Larry Peyser, Kathy Schulz, Wesley Sloan, LaVerne Speca,

Motion to approve the minutes of August 13 carried.

#### **Treasurer's Report**

The Treasurer is traveling, so there was no treasurer's report. There was, however, a treasury – budget discussion, which led to some issues to be resolved.

Kathy Schulz reported there are 224 current Academy Members:

Annual Members	81
Fall Semester Members	141
Newly Identified unclassified	2

With a projected Spring 2011 addition of 75 new members and carryover of all 141 and 2 unclassified Fall 2010 members we calculated a surplus of \$1,650 against our \$24,500 membership dues budget line item. The unknown is the Fall Semester Carryover, which we assumed would be 100% of 143. Our margin is \$1650/50 = 33 spring members less than the projections of 75 new plus 143 carryover members. This back-of-the-envelope analysis led to discussions regarding per class fees, changing annual and semester membership fees, eliminating semester membership.

Additional discussions centered about class registration and less than full attendance, waiting lists, and attendance incentives.

There were no motions or resolution regarding these issues.

The Board received invoice for two annual continuing scholarships totaling \$3500.

Action: The Board will act on the invoices for two annual scholarships identified above. Action on these invoices will be deferred until confirmation of the projected surplusl identified above and the Carryover Action items listed below.

#### Carryover Actions

<u>Action:</u> The Academy Board will meet in regular session October 1, 2010 with Vice Chancellor Dr. Deidre Martin to discuss and resolve issues pertaining to student fee calculation.

<u>Action:</u> Treasurer Rick Arkin was asked to provide a review and capitulation of the Academy's endowments to the University.

Action: Treasurer Rick Arkin was asked to analyze the effect of the increased USCA Academy student fees on the Academy's ability to maintain or increase scholarship funding.

#### COMMITTEES

- <u>Curriculum Committee:</u> Wesley Sloan reported for Susie Sadowski. Curriculum Chair – elect, the Mc Donald's are collecting attendance data for analysis.
  - Sixteen (16) classes and three (3) events are identified, subject to schedule, for the Spring 2011 Semester.

<u>Public Relations:</u> LaVerne Speca reported on preparations and needs for the Academy Booth at the Senior Extravaganza scheduled for September 15 at Odell Week's Center from 8AM to 2PM. Knowles and Kathy Schulz will set up the booth and man the early shift.

LaVerne questioned whether the Academy has members from Augusta, and do we wish to advertize and / or submit article for publication in the Augusta Chronicle.

Action: LaVerne Speca will submit an Academy for Lifelong Learning descriptive article to the Augusta Chronicle and the Aiken Standard for publication.

<u>Carry Over note from August 13</u>: Erna Arkin and Elizabeth Majors will follow up and come back to the Board with a plan and request regarding the glass display cases on the USCA Library second floor. Neither Erna nor Elizabeth was present.

Friday Meeting attendance was discussed. We have a fall schedule complete. In addition to the request Glenn made of the Board to provide feedback for discussion at future Board meetings, he has been asking Class Liaison's to promote the Friday General Meetings in each class

The Spiral and Web Site - Doug Wilson advises The Spiral is ready to go, pending receipt of minutes and Presiden'ts message. He has received an article from Susie Sadowski in which she discusses Class Sign-up and Wait Lists. Doug advised that committees are invited to submit articles for publication at <u>spiral@gforcecable.com</u>. Typical deadline is the 15<sup>th</sup>.
