Are YOU a No-Show?

With the first round of fall classes under our belts, a disturbing trend is developing. Too many people are registering for classes but failing to attend *any* of their sessions. Where classes could only accept a limited number of students due to available classroom size, there often is a wait list of people whose registration for the class could not be accepted. When registrants fail to attend such classes, a place that could have gone to another interested person on the wait list goes to waste.

Here's how our first eight courses this fall have measured up in this regard. The No-Show counts are those who attended NONE of the sessions and failed to call to cancel:

C.O. Perry Sculpture

Editor's Note: This is a continuation of the USCA historical narrative begun in last month's President's Message.

"Bob Penland and Owen Perry were close friends. They moved to Aiken around the same time. They lived in the same hotel in the beginning. They both loved Aiken, and were well received by the Aikenites," according to Owen's son, Charles.

Owen Perry was a geologist and business man. He discovered a valuable deposit of heavy minerals in the Horse Creek Valley near Aiken in 1951. He organized the money, equipment and men required to extract the minerals for profitable use. It is probable that Owen Perry had several excursions with Bob to see potential and developing properties, maybe in a jeep.

Charles O. Perry, the son, and quoted above, is a world recognized and appreciated artist. Penland family lore has it that Bob and Charles toured the nascent USCA campus (in a jeep?) while the first (now Penland) building was under construction. When shown the courtyard Charles envisioned the theme of a sculpture for the space. Today the centerpiece of the courtyard is a work of art entitled "Double Knot", dedicated to his parents, Owen H. and Florence F. Perry, signifying the bond of marriage. It also symbolizes the entwining of the Aiken community and the University. The Academy for Lifelong Learning represents one aspect of that knot's bond.

Please view www.charlesperry.com for more of his amazing work. We are most fortunate to have one of his sculptures here in our midst in Aiken. And for those scientists among us, much of his work has its foundation in mathematics.

Summary of Board Meeting of October 1

President Glenn Knowles called the meeting to order at 9:10 a.m. Those present were: Vince Coughlin, Dick Baxter, Richard Arkin, Doug Wilson, Larry Peyser, Kathy Schulz, LaVerne Speca, Jerry Mc Donald, Mary Anne Cavanaugh,

The minutes of September 10 were approved with one editorial change.

Treasurer's Report

The most current financial report is tracking very close to our budget projection. The increased Continuing Education Line Item has reduced our surplus position such that there are insufficient monies to provide scholarship funding at current levels. Inability of Vice Chancellor Dr. Deidre Martin to attend the Oct 1 board meeting to discuss issues pertaining to student fee calculation forced a delay in resolving this issue.

Action: Action on scholarship invoices will be deferred until resolution of the Continuing Education charges and determination of resulting surplus.

Action: As soon as possible after Dr. Martin's return the Board President Appointed Committee (President, President Elect, and Treasurer) will meet with her.

[Editor's Note: The meeting with Dr. Martin was held Oct 12 and the student fee issue was resolved for this academic year. The support fee the Academy pays USCA was set at \$17.50/student/semester.]

Treasurer Rick Arkin detailed the Kauffman, Watson and Academy endowments in terms of purpose, principal value, 2010-11 allocations and spendable amounts.

Committee Reports

<u>Curriculum</u> – Jerry McDonald reported for Chairwoman Susie Sadowski that written descriptions of all seventeen classes and three events have been received by catalog editor Wesley Sloan.

Dick Baxter reports a total of 28 no-shows, meaning persons missed all classes, for the four classes for which he is liaison. Some of these four classes have waiting lists of members who were unable to register. This fostered discussion without action to add a course fee to encourage class attendance.

<u>Public Relations</u> – LaVerne Speca advised that the Senior Extravaganza effort was a success in that over forty persons added their names to our mailing list. The Drawing for Membership enhanced the draw of people to the Academy table, which was recognized by Glenn Knowles as well appointed.

Glenn recommended we continue to subscribe to the Senior Extravaganza.

Action: LaVerne has contacted the Aiken Standard and will continue to follow-up with the person contacted. LaVerne will continue to establish contact with someone representing the Augusta Chronicle.

Action: Carry Over note from 8/13/10: Erna Arkin and Elizabeth Majors will follow up and come back to the Board with a plan and request regarding the glass display cases on the Aiken Library second floor. Neither Erna nor Elizabeth was present.

<u>The Spiral and Web Site</u> - Doug Wilson advises the October issue of *The Spiral* has been issued. The USCA Academy for Lifelong Learning web page now contains the revised Academy By-Laws.

<u>Membership</u> – Kathy Schulz reports two-hundred-twenty-four (224) current members. This compares with two-hundred-forty-three (243) members at this time last year. Kathy also reported there are thirty-six people signed up for the Fall Steeplechase.

Friday Meeting attendance was discussed. We have a fall schedule complete. In addition to the request Glenn made of the Board to provide feedback for discussion at future Board meetings, he has been asking Class Liaison's to promote the Friday General Meetings in each class.

OLD BUSINESS

<u>Kauffman Award</u> Vince Coughlin is seeking nominations for the award. He asks that each member of the Board be prepared to suggest and / or vote on a Kauffman Award day speaker.

<u>Cedar Creek</u> Kathy Schulz advised the Board of articles, e.g., microphone, card table, suitable to provide as token appreciation for the use of their facilities on an ongoing basis. She wishes to defer action until a later date.
