President's Message

SOUTH CAROLINA AIKEN

The Academy's annual Kauffman Award luncheon is planned for April 23, 2015 at noon, on the USCA campus (Room 116 of the B&E Building). All members of the Academy will be invited. There is no additional charge (it's included in your Academy membership), but an RSVP will be required. More details will be sent to members via e-mail or postal mail. There will be a brief Academy business meeting following the luncheon to elect 2015-2016 officers and to consider proposed revisions to Academy bylaws. The proposed bylaw revisions and slate of officers were published in the March 2015 issue of *The Spiral*.

Earlier this academic year, an Academy member pointed out the relatively small number of handicapped parking spaces in Parking Lot C, near the B&E Building where many of the Academy's classes have been held this year. This observation was passed on to the university administration, with a request they consider adding more such spaces. The university seems to have taken advantage of good weather during spring break to repaint the lines in that parking lot. In the process, they increased the number of handicapped parking spaces near the west entrance of the B&E building!



MINUTES OF FEBRUARY BOARD - Approved

TREASURERS REPORT - Laura Anderson

The Treasurer's Report was distributed. Finances are holding in good shape. Anticipated expenditures for the remainder of the semester should leave us at the end of the academic year with roughly the amount we started with in the beginning of the year, so this year's income and expenses appear to be in balance.

Instructor payments to retired faculty members through the USCA accounting system create a large amount of paperwork, both for Laura and the retired faculty member. This has gotten worse thanks to the Affordable Care Act. Paying retired faculty with a check from our checking account would bypass this USCA paperwork. Our current funding of the checking account (Board member enrollment fees go to the checking account instead of the general fund) would be inadequate to cover this use. One way to augment the checking account funds would be for the enrollment fees for both Board members and their spouses to go into the checking account. Further discussion was tabled until the fall, when next year's USCA paperwork requirements can be assessed.

CURRICULUM COMMITTEE – General discussion only, as Committee Chair not present.

Neither of the two courses starting in April are full.

A survey of the waitlist for the planetarium event showed insufficient interest to schedule a second session.

Due to popular demand, there will be another line dance class next fall if a suitable room can be obtained.

PUBLICITY COMMITTEE REPORT - Nancy Meinhardt

The last article Nancy submitted to the Mature Times monthly supplement to The Aiken Standard was not placed, although the paper did print the photo of the Line Dancing class she sent them. Since the paper did ask if she wanted to place an ad, there was a discussion of whether ad purchase may help with the likelihood of placement of submitted articles. The Board voted to authorize placement of an ad in the August issue.

There has been no progress on placing an article in the

Cedar Creek magazine. Laura is to provide a copy of the magazine to Nancy. Several Academy members living in Cedar Creek are needed to be interviewed as the basis for the article. Ken Brace was suggested as a good candidate to start with; Laura will provide Nancy with Ken's contact information.

We returned to a previous discussion of a rack card for use as a publicity handout. Doug Cook will be presenting the Academy at an Aiken Newcomers meeting in May and he'd like to have these available by then. He will send Doug Wilson a list of fall courses that can be placed on the back, and Doug W will then provide Laura with a document file to have printed, either commercially or at USCA.

There was a small article in a recent Aiken Homes and Lifestyles magazine promoting the Academy. The wording appears mostly to have been taken from our website. We are pleased with this unsolicited publicity. Perhaps this magazine can be a vehicle for future articles.

OLD BUSINESS

USCA Continuing Education Department Reorganization The new Director, Ashley Moore, has been named and just started this week. Her full title is Director of the Office of Lifelong Learning, Continuing Education and Workforce Development. She's really swamped right now, but after she's had a chance to get settled, we should consider meeting with her to inform her about the Academy and establish a relationship. Ashley's assistant, Amy Westra (Administrative Assistant & Calendar/Space Reservations Administrator for the Office of Lifelong Learning, Continuing Education and Workforce Development, whew!), is now in place full time in Laura Anderson's office. Laura's future beyond this semester is still uncertain, as she has not been offered a new contract to continue.

Officer Elections - Doug Cook has agreed to serve as President for next year. Our slate of officers for next year was published in the March issue of The Spiral, thus meeting our advanced notice requirement before the election at the April Kauffman luncheon. We still lack candidates for President Elect and Curriculum Chair Elect.

Proposed Change to Bylaws - A proposed Bylaws amendment eliminating the Membership Committee was distributed to the Board and approved via email following the February Board meeting. It was published in the March issue of The Spiral, thus meeting our 4 weeks notice requirement.

Handicap Parking Spaces in USCA Lot C - The campus parking lot lines were repainted over spring break. In the process, the number of Handicap spaces in Lot C were increased, as we had requested. The Secretary will send a note of thanks to the appropriate University department.

Unintended Consequences of Room Assignment Changes

Over the course of the semester, we were able to move the two filled courses with the largest wait lists to H&SS 103, which is a larger room, enabling us to eliminate the wait lists. This resulted in a longer walk from parking lot to classroom causing a small number of members to drop out because of walking difficulties. The Board regrets these difficulties, however there was a definite need for a larger classroom, and this was the only one available. The number of members now able to attend these popular classes was far greater than the number adversely affected.

 ${\it Scholarships}$ - Closing the loop on discussions from the October Board:

- We met with the Advancement Department that handles scholarships on October 22.
- Two \$750 spring semester 2015 scholarships were awarded in our name, and paid for during the fall 2014 semester.
- We pledged to fund two \$1500 scholarships for the 2015-2016 academic year and requested that these be awarded to non-traditional students.
- The above disbursals of funds were approved via email vote following the October 22 meeting with the Advancement Department.
- To ensure adequate scholarship planning each year, and to protect against loss of knowledge of how this is done with shifting Board membership, it was decided to invite an Advancement Department representative to a Board meeting each fall to assist in setting up that year's scholarship plan.

Kauffman Luncheon - Plans are pretty well in place. Fred Cavanaugh will give the invocation.

Dedicated IP Number for Website - The dedicated IP mentioned last month is now in place at a cost of \$4/month. Remaining email delivery issues springing from our previous shared IP have been resolved. We are currently paying for this by working off a small credit we have in our account with the web host. The Board authorized Laura to pay the balance required to extend this coverage until our next annual website renewal in August.

NEW BUSINESS

Proposed Update of the Policies and Procedures Document - Doug W emailed a proposed Policies and Procedures update to the Board following the February Board meeting, covering two main changes: 1) elimination of the Membership Committee, and 2) meeting with the USCA Advancement Department each fall to set up that year's scholarship planning. The revision was approved, contingent upon the Bylaws change which eliminates the Membership Committee being approved by the membership in April.

Acknowledging Contributions to Academy Funds - Two contributions were made to our funds recently through USCA, one to our scholarship fund and the other to one of our endowments. The Board, on behalf of the membership, greatly appreciates these contributions. A question was raised as to whether we should send the donors letters of appreciation from the Academy. Since these contributions were made through USCA, and not directly to us, we are concerned that there would be privacy violation issues were the Academy to acknowledge these contributions. As these are tax

deductible contributions, the University has already sent letters of appreciation and confirmation.

Additional Bylaws Changes - It is too late to make any additional changes to the Bylaw revision being submitted to the members in April as we could not get anything further out to the membership in time to meet the 4 weeks notice requirement. For the next revision we need to revisit the wording regarding elections and the need to have a paper ballot if there are nominations from the floor. We believe this was intended only where there is more than one candidate for an office. Also there is no need to elect a President or Curriculum Chair when these positions will be filled by automatic progression from incumbent President Elect and Curriculum Chair Elect positions.

ADJOURNMENT

The meeting was adjourned at 3:35 pm. At this time we don't anticipate needing an April Board meeting.
